#### INTRODUCTION

Pro-Drums is the next level virtual drum plug-in. It consists of a drum instrument library made up of three different kits with six different snares! The Pro-Drums library comes with over 30 different patches in it.

Our drum instruments are made up of 24 bit WAV samples packed into our proprietary format with lossless compression. This allows us to decrease the size of the instruments up to three times by saving hard disk space and RAM.

Pro-Drums instruments have up to 4 different velocity layers, which are drum hits sampled from softest to hardest. Pro-Drums also comes with three alterations or roundrobin hits which are multiple hits within one velocity layer. The purpose of alternating hits is to make the samples sound more realistic and natural. Typically with alternating hits, it's impossible to detect sampled drums because the hits are not repeating. This will eliminate most common complaint from using sampled drum instruments, the "machine gun effect."



# Pro-Drums is natively compatible with the new line of Apple Silicon machines (Apple ARM processors).




## Installing On Mac


When trying to install Pro-Drums you may encounter this error prompt.




If so right click(control+click) and click "Open"



You will then see this prompt...but instead of an "Ok" button you will see "Open" Click "Open".





The Installer will then open as normal.




## Installing On Windows


To install on windows Double-Click on the .EXE file and follow the prompts!







#### **Opening Pro-Drums for The First Time**



When you open Pro-Drums for the first time you will be prompted to locate the samples folder.

Click on "Choose Folder" and navigate to where you have saved your samples. You will then be prompted to enter in your serial number provided to you during purchase.



Once you enter your serial you will be ready to use Pro-Drums!



## Interface Overview:





**1. The Mixer Section**: This is the mixer section where you can mix the over all volume and panning of each individual kit pieces.

**2. The Tuning Section:** This is tuning section where you can control the turning and timbre of the individual kit pieces .





**3. Master Section:** This is the Master section where you can control the master volume of the entire kit, master tuning(entire kit at once), cutoff(for filters) and the volume of the room mics.

**4. OHL/OHR Volume:** This is where you can control the volume of the Overhead mics and Cymbals






**5. Velocity Control:** This is where you control the velocity sensitivity. You can choose from three different velocity modes "Normal" which works with most midi controllers that have an average velocity sensitivity. "Weak" which works best if you have a controller with little or no velocity sensitivity. And "Strong" which works best with midi controllers that have more weighted piano action type sensitivity.

**6. Filter Control:** In this drop down you can choose between a high pass or low pass filter in which the "Cutoff" knob can control(found in master section).





**7. Patch Selector:** In this area you can choose and switch between all of the different drum patches and kits.

#### **Multi-Out Mode:**

Pro-Drums comes with 2 modes "Stereo" which allows everything to come out of stereo channels 1-2 and "Multi-Out" which allows you to separate each kit piece into 11 different channels. In the patch list you will see a "Stereo" version and a "Multi-output" patch. In order to get sound from a Multi-out patch you MUST load the multi-out version of the plugin. If you are in stereo mode the multi-out patch will only produce sound on the kick.

## **EULA**

End-User License Agreement for Gospel Producers Pro Drums Computer Related Software

Please read this document carefully before installing the Gospel Producers Pro Drums (hereafter: Gospel Producers) software on your computer.

This agreement licenses the enclosed software to you (hereafter: Licensee) and contains warranty and liability disclaimers. By installing the Gospel Producers software on your computer, you are confirming to have taken notice of terms and conditions of this agreement and you acknowledge your acceptance of the software as well as your acceptance of the terms of this agreement.

If you do not wish to do so, do not install the software. Instead, provided you purchased a boxed product, promptly return the entire package, to the dealer from whom you have obtained it, for a full refund. #### 1) DEFINITIONS

"End-User License Agreement" (hereafter: "EULA"), means the contractual conditions between you and Gospel Producers for the use of the "Gospel Producers Product" and means the right to use this non-exclusive license agreement.

"Gospel Producers Product" (hereafter: "Product") means the software program, the related documentation, models, multimedia content (such as animation, sound and graphics) and all related updates supplied by Gospel Producers.

"Not For Resale" (hereafter: "NFR") means a version of the Product, so identified, intended for review and evaluation purposes only.

"Intellectual Property Rights" means worldwide common law and statutory rights associated with (i) patents and patent applications; (ii) works of authorship, including copyrights, copyright applications, copyright registrations and "moral" rights; (iii) the protection of trade and industrial secrets and confidential information; (iv) other proprietary rights relating to intangible intellectual property (specifically excluding trademarks, trade names and service

marks); (v) analogous rights to those set forth above; and (vi) divisions, continuations, renewals, reissuances and extensions of the foregoing (as applicable) now existing or hereafter filed, issued or acquired.

#### 2) LICENSE

The Product is protected by copyright laws and international copyright treaties, as well as other intellectual property laws and treaties. The Product is licensed only. The intellectual property of the Product remains at Gospel Producers.

This EULA grants you the non-exclusive right to use the Product for a maximum period of 30 (thirty) years. All other actions and means of usage are reserved to the written permission of the right holder Gospel Producers.

The Product is only for your personal (individual) use.

You may install and use the Product, or any prior version thereof for the same operating system, on up to three (3) computers, provided that (a) each computer is owned by (or leased to) and under the exclusive control of the Licensee; (b) the Product shall NOT be used simultaneously on more than one machine, and (c) any computer(s) with the Product installed shall not be sold, rented, leased, loaned or otherwise be removed from the Licensee's possession without first removing (uninstalling) the Product, except as provided in Paragraph 4.5 (below) pertaining to "Software Transfer".

You may also store or install a copy of the Product on a storage device, such as a network server, used only to install or run the Product on your other computers over an internal network; however, you must acquire and dedicate a distinct license for each user of the Product from the storage device.

Any given license for the Product may not be shared or used concurrently or otherwise on different computers or by different users in a given organization.

#### 3) AUTHORIZATION

The Product only functions upon completing the registration and authorization procedure described in the accompanying user documentation.

The registration and authorization procedure requires to create a user account on the Gospel Producers website and to provide the requested information about yourself, in accordance with Gospel Producers privacy policy (www.GospelProducers.com/privacy).

If you provide any information that is not correct or incomplete, or Gospel Producers has reasonable grounds to suspect that such information is not correct or incomplete, Gospel Producers has the right to suspend or to revoke the license.

The termination of the license shall be without prejudice to any other rights, whatsoever, of Gospel Producers.

Once the Product is registered it is associated with your user account and it can not be returned or transferred to any third party without obtaining the prior written consent of Gospel Producers.

#### 4) DESCRIPTION OF OTHER RIGHTS AND LIMITATIONS

4.1 Limitations on Reverse Engineering, Decompilation, and Disassembly

The Product is licensed as a single product. Its component parts may not be separated for use on more than one computer.

You may not reverse engineer, decompile, or disassemble the Product, except and only to the extent that such activity is expressly permitted by applicable law.

#### 4.2 Sound License Agreement

In case a sound library is part of the Product, it is subject to the following terms in addition to the EULA:

All sounds and samples in the Product are licensed to you for commercial and non-commercial use in music and audio production, public performance, broadcast or similar use.

Re-distribution of this Product, its sounds or their derivatives, through any means, including but not limited to, re-sampling, mixing, filtering, processing, isolating, or embedding into software or hardware of any kind, is strictly prohibited.

Furthermore all these sound and samples may not be repackaged in whole or in part as audio samples, sound libraries, sound effects or on a stand alone basis.

#### 4.3 Not For Resale

If the Product is labeled "NFR" or "Evaluation Copy", then, notwithstanding other sections of this EULA, you may not sell, or otherwise transfer the Product.

#### 4.4 Rental

You may not rent, lease, or lend the Product to any party.

#### 4.5 Software Transfer

You may transfer your rights as Licensee of the software or any Gospel Producers product, as licensed to you under this agreement only with purchasing a license transfer on Gospel Producers official website. The abovementioned transfer license can be combined with a single "Gospel Producers Product", and just only once.

Gospel Producers reserves the rights to:

- I) delete or cancel, at its sole discretion, the necessary serial number for the registration, if purchased fraudulently or, in any case, against the law.
- II) forbid, at its sole discretion, any transfer of the necessary serial number for the registration, before the term of 90 days starting from the serial number or license transfer purchasing order.

The Product may be transferred or otherwise made available to any third party only with the prior written consent of Gospel Producers and provided that (a) the original media and license(s) accompany the Product and (b) the party transferring the Product does not retain a copy of the Product.

In any case the concerning law is reserved, if applicable.

#### 8) WARRANTY CLAIMS

Gospel Producers or its authorized dealer will use reasonable commercial efforts to repair or replace the product and return it to you or issue to you a credit equal to the purchase price, at its option.

#### 9) LIMITATIONS ON WARRANTY

Gospel Producers warrants only that the Product will perform as described in the user documentation. No other advertising, description or representation, whether made by a Gospel Producers dealer, distributor, agent or employee, shall be binding upon Gospel Producers or shall change the terms of this warranty.
